Lenten Discipline

As we enter the Lenten season, it is a good time to choose how we will use this Lent to further our growth, build our faith, and strengthen our commitment to being the Body of Christ. First Church Lay Leader Pat Mosley has prepared a powerful resource for our Lenten discipline called "A Walk Through Lent." We will make this available to the congregations, and I strongly encourage you to accept this challenge. I know that you will find it a great blessing.

In addition to Pat's offering, we will be using a playlist of pop songs to help guide our contemplation during worship for Lent. We will hear one of these songs in each worship service throughout the Lenten season. This is unusual, but God is found in many places and through many means. One of the things that we can learn from this is to experience God in unexpected places and in unexpected ways, to discover that God is present in all things and everywhere.

God is good, and God is always reaching out to us. There is so much noise and so many distractions in the world that it is easy to overlook the loving grace that constantly surrounds us. I believe that God's grace is powerful. I believe that God's grace is transformative. I believe that God's grace enables us to do more and be more than we can ever comprehend.

This Lent, pay attention to what God is doing. Look for the signs of God's grace all around us. Let God's grace sustain us and help us to continue this long journey that we call life. Commit yourself to the path that we are on, individually and as churches. I know that the results of both paths may seem slow, and we may not always understand, but I believe that if we have faith, pray, and practice the spiritual disciplines this Lent and beyond, all will be well.

In preparation for forming a new church, we are implementing a new church software system complete with a new church website. We are doing this in two phases, beginning with First Church (because First's current system is easier to move to the new system), then combining Woodmar into it in the near future. Why is it Taking So Long?

Why is it taking so long? Members of the Merger Team have been hearing this a lot, even from our own families! We understand how everyone is feeling, because we feel the same way. The process is taking longer than we expected because there are so many issues to consider. Our Merger Team members are Pastor Jim Denton, Pastor Pete Ward, Bob Brown, Jane Harper-Alport, Niki Avina, Cyndi Slaboski, Fran Vukovich, and Mary Zaikis. Fran took over for Nancy Craig, who stepped down due to her new job responsibilities.

What We've Been Doing

The Merger Team has been meeting regularly since May, 2023. We began by learning about each church's buildings, programs, missions, worship style, and finances. We also spent some time creating a vision for the future church. Recognizing that we need to address the root causes of our current situation so that we do not continue down the path of decline, we spent a lot of time discerning what cultural shifts we will need to make and how we will make those deep changes to our mindset, practices, and attitudes. That has been a lengthy and ongoing process.

Then we began discussing the many decisions that need to be made for our merger. Since the members of the Merger Team feel strongly about some of these issues, there was sometimes a lot of discussion! We all care deeply about the future of our newly merged church and want to make the best decisions possible. Some of the things we have discussed (including several issues that we are still working on) are:

- Which building will we use? What happens to the other church building? (It took about ten months to get appraisals on both buildings.)
- If the unused building is sold, how will profits from the sale be used? The UMC Book of Discipline restricts these funds for capital improvements and pastor housing needs, but Conference leadership may make an exception.
- Depending on which building is chosen, what happens to The Vine Food Pantry, Brianna's Hope, Messy Church, Community Preschool & Childcare, Woodmar's many AA groups, and First's Wednesday Bible Study and Quilting Group.
- How do we keep the congregation informed and get feedback from them? (town hall, listening session, newsletter articles, etc.)
- What process will we use to choose a name for the new church?
- What will be our future financial structure and budget? What finance software will we use?
- Who will hold various staff positions and what will their salaries be? Can we afford an outreach pastor?
- ·How will the assets of the two churches' respective Foundation (First Church) and Endowment Fund (Woodmar) be handled?
- ·How will the funds from the sale of First's parsonage be used? Are we keeping or selling the Woodmar parsonage? If sold, how will these funds be used? (As noted above, the UMC Book of Discipline restricts these funds for capital improvements and pastor housing needs, but Conference leadership may make an exception.)
- How will we structure the new Church Council and committees?
- What expenses will we have for this merger, such as new signs, moving costs, modifying class rooms, new location for The Vine Food Pantry, and other building remodeling?
- What are the projected long-term capital plans (5, 10 and 20-year) for the merged church and what are the recommendations for how they will be funded?
- What are the short- and long-term funding plans for the Community Preschool & Childcare?
- Each church uses a different software to keep track of membership. How will we handle that?
- What is the procedure for the final vote?

Why can't we merge now and take care of these details later?

When it comes time for an official vote, we will be voting yes or no on a proposal prepared by the Merger Team. It will include every significant detail we can think of and even things that we didn't think of, but our attorney did. The proposal must be very detailed so we know exactly what we are voting for. There could be a lot of hard feelings if people assumed things were going to be a certain way and then discovered was not what they were expecting. We want to make sure that there are no misunderstandings.

What is happening now?

We are currently in the process of developing responses to the above-listed questions that are undetermined at this point. After the Merger Team agreed on the need to obtain legal counsel, we entered into an agreement of engagement with an attorney in early December. In the past three months we have been responding to questions and providing a lot of documentation for the attorney. He will advise us on the elements of our merger proposal and prepare the legal side of the proposal, called a Memorandum of Understanding, which is required by the Indiana UMC Conference.

As you are now aware, plans are to use the Woodmar building and sell the First UMC building. Decisions have been made on many of the above issues, but there are many significant issues still under discussion, which will need to be resolved before the attorney can proceed. We are very aware that everyone is tired of this process and wants it to be completed. So do we!! We will do our best to speed things along while still making careful, responsible decisions and will continue to inform and respond to questions from our congregations.

After our work is completed, we will draft a detailed Merger Proposal that we will share with our respective Church Councils to obtain feedback. The final proposal will be submitted to the congregations, who will be given time to look it over. Then in-person charge conferences will be conducted for each church and eligible members will cast their official votes. If a majority of those present at each charge conferences vote "Yes," the actual date of the merger will be a couple of months later. Let's all just hang in there over the coming months! We will get there!

Building Relationships





Finance and Administrative



First UMC Finance News

The First Church Finance Committee held their second meeting of the new year on February 20. Those present included Church Council Chair Jane Harper-Alport, Financial Secretary Pam Longhi, Treasurer Larry Alport, and Finance Chair Pete Ward.

The church received \$8,060.85 in offerings and gifts during January, as well as other income from building use; donations for Second Mile Giving, UMCOR relief, and Wednesday Bible Study; payments for altar flowers and SCRIP; and miscellaneous income, all of which brought total income for the month to 9,921,72. However, total church expenses for January were \$20,965.99. These expenses were made up of salaries, missions, conference tithes, office expense, property and utility expense, and pastor's pension and health insurance. The result is that the expenses for the month exceeded income by \$11,044.27.

The checking account balance as of January 31 was \$384,855.56. However, this balance is entirely made up of restricted funds that represent proceeds from the sale of the parsonage, and designated funds for Memorials, Second Mile Giving, The Vine Food Pantry, SCRIP, and several other accounts. Unfortunately, we are continuing to use restricted and designated funds simply to keep the church open during the merger process.

The Finance Committee continues to work with the Church Council and the FUMC Foundation to establish an operating budget for 2025 that will allow us to meet our financial obligations. Our fixed costs continue to exceed our monthly giving by approximately \$3,000.

January Financials for Woodmar ended with expenses over income of \$88.04. We had \$26,732 cash in bank at the end of the month. Offering for the month was \$10,986. No unusual expenses were made. Community Preschool and Childcare had income over expenses of \$4,554 with \$87,835 cash in bank. Their year-to-date (August - July) bottom line is expenses over income of \$26,718. Let's pray for a great new year!!
